STATIONS OF THE BCH – DOSTYK / ALTYNKOL

FORWARDER RATE INCLUDES THE FOLLOWING:

provision of platforms for organizing the dispatch of empty containers/car for loading at the start station of the route without paying the tariff;

rail rate and customs duty for the Russian Railways for a loaded container;

fitting platform provision on the route, as well as five (5) days of the rail fitting platform location at the start station of the route for loading and customs clearance of transportation documents before the transfer of the loaded rail fitting platform to the Forwarder;

charges for cargo convoy and cargo protection within the territory of Russian in accordance with effective rules for cargo transportation by rail;

information services along the whole route.



In case of tariff rates change on cargo transportation by the Kazakhstan, Russian, and Belarusian railways, the Forwarder retains the right to change the rates specified in this information letter with prior notification of a Customer on the rate level and effective date. The change of tariff rates are not applicable to the cargoes with dates of transportation agreements (specified in the impression of date stamp of a dispatch station in respective consignment note of the Agreement on International Goods Transport by Rail [SMGS]) preceding the date of notification.
